Performance

Testing - Fire

The FDS Complete™ Range has undergone successful extensive testing for fire resistance at major independent UKAS accredited test houses.

Double and single doorsets are tested for and exceed thirty minutes fire resistance in a series of large full scale tests specific to half hour fire rated doorsets including side panels/screens and fanlights.

Double and single doorsets are tested for and exceed sixty minutes fire resistance in a series of large full scale tests specific to one hour fire rated doorsets including side panels/screens and fanlights.

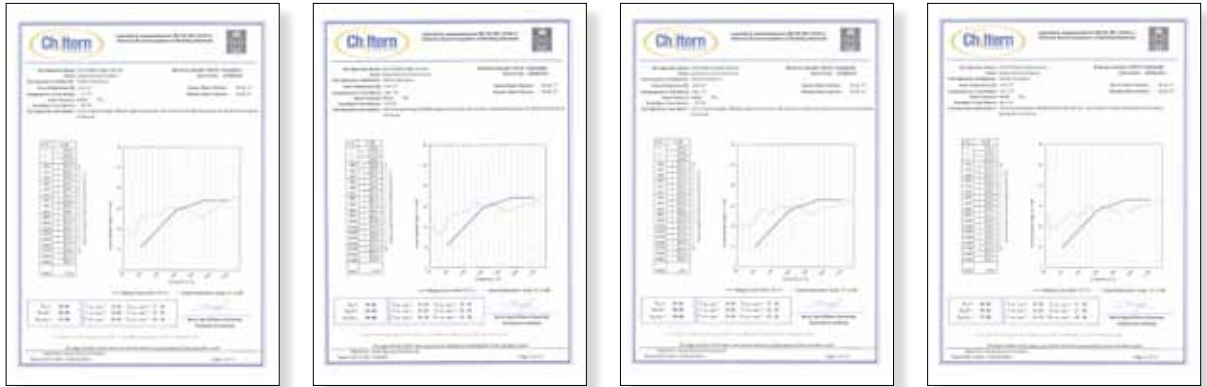

Testing - Acoustics

Gerda has carried out tests on the FDS Complete™ Range of doorsets for acoustics to meet the requirements of Building Regulations Part E. This includes testing single and double doorsets for both FD30(S) and FD60(S).



Testing - Smoke

“comprehensive full scale smoke tests”

Successful full scale smoke tests have been conducted on the FDS Complete™ Range of doorsets to EN1634-3:2004 for smoke. This includes testing single and double doorsets.



Certification

The FDS Complete™ Range carries third party certification through the notified body BM Trada.



BM Trada check that products demonstrate high performance through independent testing against exacting requirements and ensure consistent manufacture through approved quality management systems.

Smoke Control

The FDS Complete™ Range of communal doorsets is designed to perform effectively in the event of smoke. The doorset below underwent a severe fire which melted the floor.

The smoke damage can be seen to the fire side of the door. The door operated as designed, protecting the compartmented area and prevented the seepage of smoke. It continued to function until it was replaced.

Gerda fully tests its fire doorset ranges in large scale smoke tests at UKAS accredited test houses to EN1634-3:2004. This includes doorsets and large screens and side panels as well as fanlights.

After a full scale fire, the Gerda® doorset still functions.



The doorset performs with no smoke damage in the compartmented area.



Fire Safety Seminars

SECURITY



The Environment

The location of the doorset is important - if this forms part of a firefighting area, it may be that the compartmentation requirements are for a one hour, as opposed to a half hour, fire doorset.

If the doorsets are in an environment which is regularly exposed to wilful damage through vandalism or just general lack of care, the need for replacement of the doorset or component parts, such as door closers, may be frequent.

There is the added legal requirement that if the doorset does form part of a firefighting area, then this area must be maintained under the RR(FS)O. By looking at the design of the doorset, cost savings can be made in terms of maintenance, while at the same time assisting with this requirement.



The Prevention and Control of Arson

In its latest edition of **'The Prevention and Control of Arson**, the Fire Protection Association states:

"To ensure fire doors continue to operate as they are designed to do so (given their role in compartmentation), consideration may need to be given as the doorset type specified for an environment. Certified doorsets with in-built features to prevent vandalism may be an option for more onerous environments."

DESIGN

The FDS Complete™ Range



The FDS Complete™ Range offers beautifully finished FD30(S) and FD60(S) single and double doorsets with the option of screens and panels all tested **as a complete doorset**.



Construction

This range is tailored to suit your building structure openings. It comprises 54mm or 44mm engineered timber core door leaf and a hardwood frame. The doorset is tested with all hardware and signage in full scale tests.

Features

All frame finishes are supplied in white as standard to assist with contrast of colours for the partially sighted.

The door closer is factory fitted and tested to ensure smooth operation and quiet closure. This is a concealed closer preventing accidental damage to walls and making itself less prone to damage. There is the option of surface mounted closers if required. Both options are manufactured to BS EN 1154

The stainless steel D handle is ergonomically designed and manufactured to Gerda specification GFH3450 and positioned so that it can be reached and gripped by wheelchair users.

Smoke Control

The latest photoluminescent signage assists those who are partially sighted as well as those needing to quickly identify a means of escape in a smoke filled environment. The sign incorporates "Fire Door Keep Closed", the manufacturer's identification and "FD60(S)" or FD30(S) in line with BS9999:2008.



The 3tiervision™ panel is able to withstand a high level of accidental or deliberate misuse. It seldom requires replacement. However should this become necessary, it is fitted with security screws to enable this to take place. The glazing in both the door and side screens is coded and has security fixings to enable efficient replacements.

The FDS Complete™ Plus Range

The FDS Complete™ Plus Range with enhanced security in FD30(S) and FD60(S) single and double doorsets with the option of screens and panels all tested as a complete doorset.



Construction

This robust range is tailored to suit your building structure openings. It comprises a beautifully finished 54mm or 44mm engineered timber core door leaf and hardwood frame. The doorset is tested with all hardware and signage in full scale tests.

Anti-vandalism Features

The concealed overhead door closer prevents wanton damage and breakage from misuse. The door closer is factory fitted and tested to ensure smooth operation and quiet closure. Stainless steel hinges with security studs are factory fitted to ensure the correct tolerance.

The 3tiervision™ panel is positioned to prevent deliberate breakage. The system is designed to withstand a high level of accidental or wanton damage. It has sustained axe attacks, after which the doorset has been able to function as it should. The glazing system is fitted with security screws to enable replacement should it become necessary. The glazing in both the door and side screens is coded.



Axe attack on the anti-vandal 3tiervision™ panel. The fire door is still able to function with no breach to the inner section of fire resistant glazing.

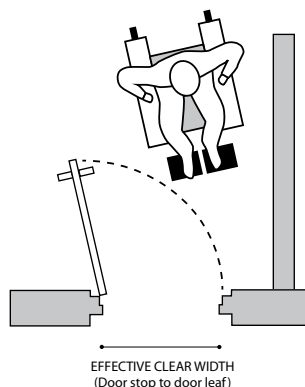
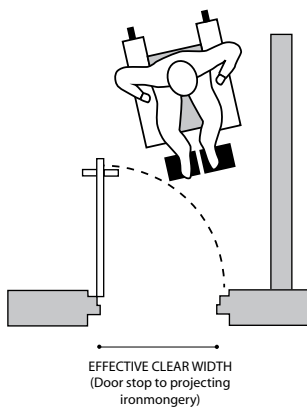
Smoke Control

All intumescent seals are factory fitted in line with doorset design and testing. These seals effectively resist the passage of smoke. This is because they are manufactured from a material that is unaffected by moisture or atmospheric carbon dioxide making them less prone to degradation which in turn causes ineffectiveness. It is important that the seals are fitted correctly for all areas: frame, glazing, hinges and door leaf.

The automatic drop down seal is an important feature of the doorset design. This requires no electrical connection and automatically drops down during the last few millimetres of the door closing, thus preventing the passage of smoke between the bottom of the leaf and the floor. Fully intumescent-lined, it acts together with the doorset edge to provide conformity to EN1634-3:2004 and is in line with BS9999:2008.

Intelligent Systems

Investment into bespoke software has led to enhancements in surveying and manufacturing processes. Dimensions and data are automatically cross checked throughout the ordering system so that doorsets meet part M and the scope within Gerda's extensive fire test remit.



Part M Mobility Building Regulations

To ensure accessibility for wheelchair users, a clear opening of at least 750mm* is required for existing buildings and 800mm for new. Users must be able to reach and grip handles.

*Where an existing building structure does not allow for this, Gerda highlights this from the survey.

Opening and Closing Forces

A fire resisting doorset must close to be effective and circumstances may arise which need to take into account air pressure or smoke seal considerations. BE EN 1154 states that door closers of less than power size three are not suitable for fire resisting doorsets.

The FDS Complete™ Range can be used in conjunction with automatic hold open devices to assist with opening.

Interlocking Frames

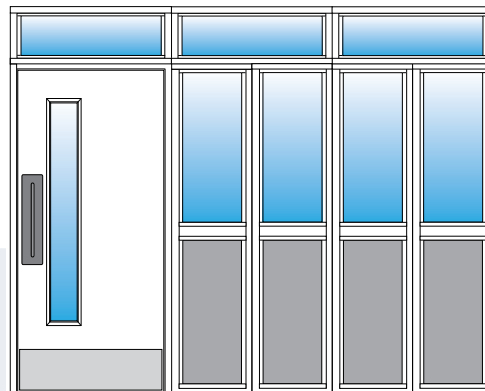
The FDS Complete™ Range is designed with interlocking frames to enable easy fitting on site and to assist with the correct installation of the doorset and its side or top screens/panels.

When replacing an old door with a new tested and certified fire doorset, it is important that the top and/or side panels perform to the same required level. The level of compartmentation needs to be maintained, so top and side panels whether glazed or solid, need to perform effectively to the required level of 60 minutes or 30 minutes.

The FDS Complete™ Range offers glazed and solid, side and top panels subject to measurements that are within the full scale fire tests and test reports under the certification scheme.

This means:

- The doorset is tailored to specific requirements
- The doorset gives a complete solution that meets Fire, Smoke, Safety and Acoustic standards
- Installation is precise and efficient owing to the specialised interlocking system.



Example of modular unit arrangement around a door screen showing location of timber joint inserts



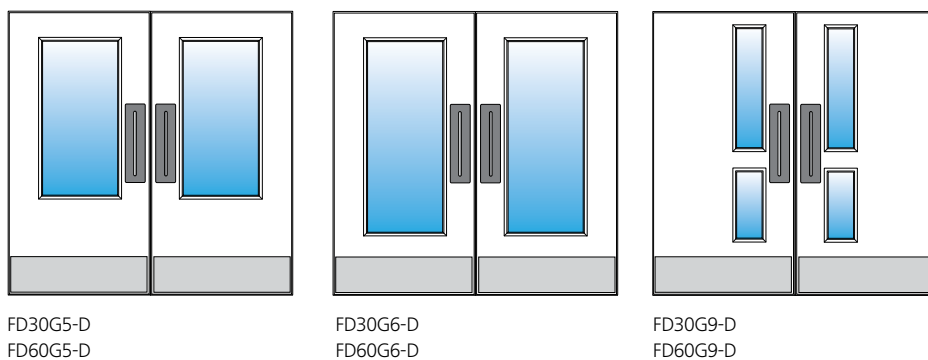
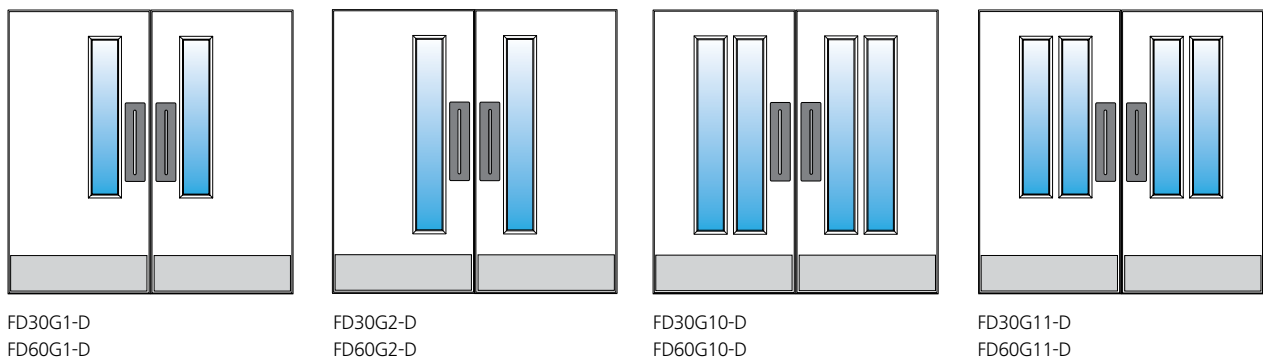
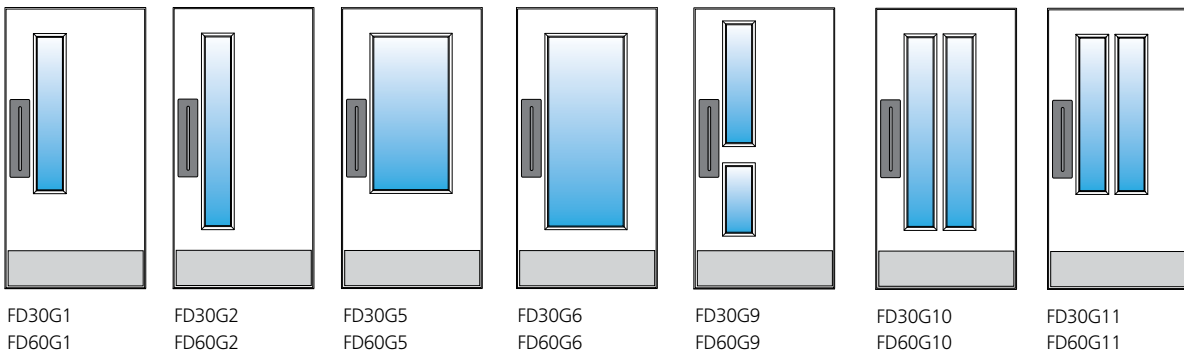

Doors replaced by the FDS Complete Range™ are recycled. Gerda’s commitment to further improving this process is through biomass biodegradability. Here replaced doors are reformed into heat bricks using a specialised process. These bricks are then used to heat the manufacturing facilities.

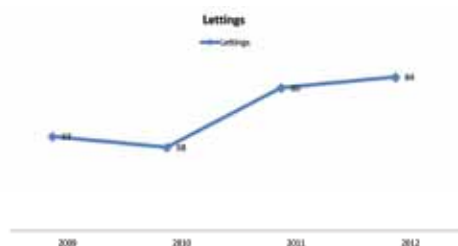
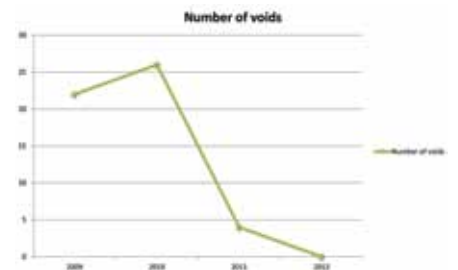
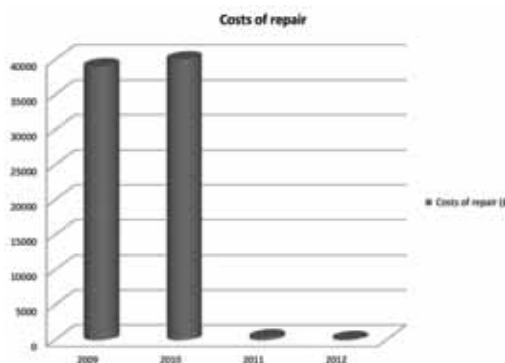

- Class O treatment to communal areas
- Sprinkler installation to bin rooms
- Smoke vents to communal areas
